Pandemic Unemployment Assistance (PUA) Ann Jackman

PUA is a new program open to the following individuals:

- Self employed, including gig workers, freelancers & independent contractor
- Small business owners, whose income is from their own business, may be eligible
- Those seeking part-time employment
- Claimants that have an insufficient work history to qualify for regular unemployment benefits
- Claimants that have been laid off from churches & religious institutions and are not eligible for regular unemployment benefits under state law
