Fishing Partnership Support Services and the Northeast Center for Occupational Health and Safety (NEC) are committed to increasing the use of lifejackets in the commercial fishing community. By listening to commercial fishermen in its “Lifejackets for Lobstermen” project, NEC learned that fishermen needed opportunities to find a lifejacket model that fit their personal needs, as well as assistance with the financial costs of lifejackets. Their “Lifejackets For Lobstermen” van toured the coast of Maine and Massachusetts in 2019 and sold over one thousand lifejackets. Fishing Partnership will continue to provide a similar opportunity and financial assistance through our Safety Training and other programs with the support of NEC.
